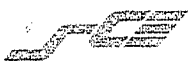

Subject: Establishment of Edison-March Air Force Base Agreement Regarding Power Allocations from the Parker-Davis Project

Southern California Edison Company ("Edison") hereby transmits for filing the following changes in tariff schedules. The revised tariff sheets are listed on Attachment A and attached hereto.

This filing establishes an Edison-March Air Force Base Agreement Regarding Power Allocations from the Parker-Davis Project ("Agreement") and revises Edison's List of Contracts and Deviations. The Agreement establishes the terms and conditions of an arrangement whereby March Air Force Base ("March") can benefit from the capacity and associated energy allocated to March by the Western Area Power Administration ("WAPA") from the Parker-Davis Project. This filing also withdraws the Department of the Air Force, Norton Air Force Base Agreement ("Norton Agreement"), executed on March 13, 1991, and Department of the Air Force, George Air Force Base Agreement ("George Agreement"), executed on March 13, 1991, and removes them from Edison's List of Contracts and Deviations.

The Air Force and WAPA have agreed to transfer the Parker-Davis Project allocations for George and Norton to March due to the closure of those bases. Under the Agreement, Edison shall schedule WAPA power for the Edison control area and March shall receive a credit from Edison on its monthly billing under Schedule TOU-8 for both energy and capacity components of March's Parker-Davis Entitlement.

The Agreement replaces the existing Norton and George Agreements which shall terminate on the effective date of the Agreement. Commission authorization and date will be entered on the tariff sheet when approved by the Commission.

No cost information is required for this Advice Filing.

This filing does not result in a price increase, withdrawal of service, or more restrictive conditions.

Edison believes that a resolution is required for approval of this filing. It is requested that this filing become effective on the 40th calendar day after the date filed which is October 20, 1993.

The protest must be received by the Commission no later than 20 days after the date of this filing. However, a copy shall also be mailed to the attention of the undersigned at Southern California Edison Company, 2244 Walnut Grove Avenue, Rosemead, California 91770. There is no restriction on who may file a protest, but the protest shall set forth specifically the grounds upon which it is based.

In compliance with Section III, Paragraph G. of General Order No. 96-A, copies of this filing are being furnished to the parties on the attached list.

Further, in accordance with Public Utilities Code Section 491, notice to the public is hereby given by filing and keeping open for public inspection at the Company's corporate headquarters the new schedules and the Advice Letter plainly stating the changes to be made and the time when the changes will become effective.
