However, SCE does not guarantee customer receipt of the notification.

 - d. Customer Specific Reference Level: The CSRL or the "peak average usage level" is the customer's average kWh usage during the 2:00 p.m. to 6:00 p.m. time period of the three (3) highest kWh usage days of the five (5) non-event, non-holiday weekdays immediately preceding the PTR Event. The CSRL is used to determine the customers kWh reduction for each PTR Event in order to apply the rebate.

When calculating the CSRL, the three highest usage days during the 2:00 p.m. to 6:00 p.m. time period will be extracted from the five (5) prior non-event, non-holiday weekdays. Usage from 2:00 p.m. to 6:00 p.m. on these three days will be summed for each day then averaged to produce the CSRL.
