When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday and an off-peak period. No change will be made for holidays falling on Saturday.

The summer season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year. The winter season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.

2. Basic Charge: For purposes of applying the Basic Charge, the following definitions shall be used:

Single-Family Residence: A building of single occupancy that does not share common walls, floors, or ceilings with other residential dwelling units, except as specified in the Multi-Family Residence definition below.

e. Calculation of Rebates: Rebates will be calculated based on the customer's usage during the Event as compared with the event-specific CSRL to determine if a kWh reduction was achieved. If the CSRL is greater than the recorded usage during an Event, then a reduction was achieved and the rebate amount will be calculated and applied accordingly.

(1) If the recorded usage during an Event is less than the CSRL, a credit will be applied to the customer's bill equal to \$0.75 per kWh multiplied by the reduction.

(2) For customers who have SCE-authorized enabling technology, the credit received will be increased by an additional \$0.50 per kWh reduced, bringing the total incentive factor to \$1.25 per kWh. If the recorded usage during an Event is less than the CSRL, a credit will be applied to the customer's bill equal to the incentive factor multiplied by the reduction.

4. Change of Rate Schedule: There is no minimum length of time that a customer must take service under this Schedule. In the event a customer desires to transfer to another applicable rate schedule, the change will become effective for service supplied after the next regular meter reading following the date of notice to SCE. The customer shall not be allowed to make an additional change in rate schedule until 12 months of service has been provided under the rate schedule then in effect.

5. California Alternate Rates for Energy Discount: Customers who meet the definition of a California Alternate Rates for Energy (CARE) household as defined in Schedule D-CARE, may qualify for a discount (at least 20%) off of their bill prior to application of the Public Utilities Commission Reimbursement Fee and any applicable user fees and taxes. An Application and Eligibility Declaration is required for service under this Special Condition. Customers eligible for the CARE Discount will not be required to pay the CARE Surcharge, as set forth in Preliminary Statement, Part O, Section 4 and are not subject to the DWRBC rate component of the Total charges for Delivery Service. Eligible customers shall be billed on this Special Condition commencing no later than one billing period after receipt and approval of the customer's application by SCE. Customers may be rebilled for periods in which they do not meet the eligibility requirements for the CARE Discount.

TOU kWhs are then assigned to each tier by applying the existing tiering parameters.
