[REDACTED], the Interconnection Customer (IC), received a Cluster 7 Phase I study report dated December 17, 2014 for its Interconnection Request (IR) to Southern California Edison Company's (SCE) for their proposed [REDACTED] Project (Project) interconnecting to the [REDACTED] Substation, queue position WDT1200.

Subsequent to the release of the QC7 Phase I report package for the Project dated December 17, 2014 it was determined that the Escalated Cost and Time to Construct for Interconnection Facilities, Reliability Network Upgrades, Delivery Network Upgrades, and Distribution Upgrades (Attachment 2 to Project Appendix A report dated December 17, 2014) erroneously specified a \$9k dollar value for the [REDACTED] SPS costs allocated to the Project. The actual costs allocated to the Project for the [REDACTED] SPS is \$90k.

Consequently, the document(s) below from the QC7 Phase I report package dated December 17, 2014 has been updated accordingly, and is attached as part of this QC7 Phase I Addendum report package. The corresponding changes replace and supersede those same sections in the Project's QC7 Phase I Appendix A report for WDT1200 (WDT1200A & WDT1200B).
