**SOUTHERN CALIFORNIA EDISON COMPANY
SELF-CERTIFICATION AFFIDAVIT
GENERATION MUNICIPAL SURCHARGE EXEMPTION
FOR STATE OF CALIFORNIA AND ITS POLITICAL SUBDIVISIONS**

Pursuant to California Public Utilities Code Sections 6350-6354 and Southern California Edison Company's (SCE's) Schedule GMS - Generation Municipal Surcharge, as approved by the California Public Utilities Commission (CPUC), Direct Access (DA) Customers, Community Aggregation (CA) Customers, Community Choice Aggregation Service (CCA Service) Customers, and any SCE Delivery Service Customers who receive Generation service from a supplier other than SCE, are subject to the Generation Municipal Surcharge. However, when the customer of record is the State of California or a political subdivision thereof, such customer is exempt from the Generation Municipal Surcharge.

The customer of record on the affected account may self-certify as an entity of the "State of California or a political subdivision thereof," and be eligible for GMS exemption, per the instructions below.
