QUALIFYING RV PARK ACCOMMODATION - SUBMETERED

Sheet 1

APPLICABILITY

This Schedule is applicable to domestic service including lighting, heating, cooking, and power use or combination thereof in a Qualifying RV Park where all the RV spaces of the park, or all of the RV spaces in a specific section of the park, are separately submetered and reserved for prepaid month-to-month tenants.

TERRITORY

Within the entire territory served.

RATES

The Multifamily Accommodation Basic Charge and Multifamily Accommodation Minimum Charge set forth in Schedule D and Schedule D-CARE shall apply to customers served under this Schedule. The single-family rates set forth in Schedule D shall be adjusted as follows:

Energy Charge: The baseline quantity to be billed under rates designated as applicable to Baseline Service shall be determined by multiplying the applicable baseline quantities set forth in Special Condition 8, by the number of qualifying RV units in a qualifying RV Park; plus any eligible Medical Baseline Allocations.

If any tenant in a submetered Qualifying RV Park qualifies for CARE rate assistance as set forth in Schedule D-CARE, the Baseline quantity shall be prorated among the applicable CARE Baseline rate and the regular Baseline rate according to the proportion of qualifying and nonqualifying spaces. Nonbaseline usage, if applicable, shall be prorated among the applicable CARE Nonbaseline rate and the regular Nonbaseline rate according to the same proportion as the Baseline quantity.

DMS-3 Submetering Discount: The submetering discount is zero.

Basic Charge Adjustment: Distribution charges shall be increased by \$0.024 per Qualifying RV Unit in a Qualifying RV Park per day to adjust for the Basic Charge billed to each Qualifying RV Unit.

Residential California Climate Credit: The master-metered customer served under this Schedule will receive a semi-annual California Climate Credit from the State of California for each of the submetered Qualifying RV Units on the single Premises served. The California Climate Credits are applied to the master-metered customer's April and October billing statements. In response to the COVID-19 pandemic, the October 2020 California Climate Credit of \$37 per each submetered Qualifying RV Unit will be advanced and divided into two equal credits (i.e., two credits of \$18.50 per submetered Qualifying RV Unit). The first credits will be applied to either the master-metered customer's May or June 2020 billing statement depending on the master-metered customer's billing cycle. The second credits will be applied to either the master-metered customer's June or July 2020 billing statement depending on the master-metered customer's billing cycle. As a result, California Climate Credits will not be applied to the master-metered customer's October 2020 billing statement. It is the responsibility of the master-metered customer served under this Schedule to distribute the California Climate Credits to each submetered Qualifying RV Unit.

SPECIAL CONDITIONS

1. Notification: It is the responsibility of the customer to advise SCE within 15 days following any change in the number of submetered Qualifying RV Units and any change in qualifications for baseline allocations.
2. Miscellaneous Loads: Miscellaneous electrical loads on the same meter such as general lighting, laundry rooms, Qualifying RV Park office, general maintenance, and other similar usage incidental to the operation of a Qualifying RV Park will be considered as domestic usage.
3. Nondomestic Enterprises: Electric energy used for nondomestic enterprises such as offices (other than an office used only for the Qualifying RV Park), stores, shops, restaurants, service stations, and other similar establishments will be separately metered and billed under applicable schedules.
4. Qualifying RV Park: An RV park, or portion of an RV park, where all of the spaces on the same master meter are occupied by a tenant in a RV used as a residence and renting on a prepaid month-to-month basis. The master meter shall not include nondomestic enterprises as described in Special Condition 3.
5. Qualifying Recreational Vehicle (RV) Unit: An RV Unit that is used as a permanent single-family residence at the same location in an RV park or on a single premises for at least nine months out of the year; is not used for recreational purposes; and is not removed from its space or location on a regular basis. 6. An Eligibility Declaration and/or on-site verification of books, records, and facilities may be required for service under this Schedule. If SCE's on-site inspector requires a park operator's assistance, SCE shall provide reasonable advance notice of the verification visit. (T)
7. CARE Rate Assistance: (T)
 - a. Customers receiving service under this Schedule shall comply with the provisions of Public Utilities Code Section 739.5 in providing service to their submetered tenants. This includes, among other things, providing electric service to CARE tenants under the provisions of Schedule D-CARE of SCE's tariffs.
 - b. Customers served under this Schedule shall provide application and declaration forms for the CARE rate to their submetered residential tenants. The completed application forms of eligible CARE tenants shall be mailed by the tenant to SCE.

7. CARE Rate Assistance: (Continued)

- c. When SCE receives an application from a qualifying CARE submetered tenant, the information will be forwarded to SCE's Customer receiving service under this Schedule. (T)
- d. The proration of the DMS-3 Customer's bill by SCE under the provisions of the Energy Charge shall commence no later than one billing period after receipt and approval by SCE of a qualifying tenant's application. (T)
- e. It is the responsibility of the DMS-3 Customer to notify SCE immediately of the date each CARE tenant is no longer receiving service from the DMS-3 Customer. In addition, if the DMS-3 Customer has good reason to suspect that a tenant is not eligible, the DMS-3 Customer should notify SCE. (T)

8. Failure of a DMS-3 Customer to abide by SCE's tariffs may result in a change of rate, rebilling and/or discontinuance of service in accordance with SCE's tariffs. The DMS-3 Customer's account may also be rebilled consistent with Rule 17. (T)

9. Multifamily Accommodation Baseline Allocations: The applicable baseline quantity of electricity to be billed under rates designated as applicable to Baseline Service shall be the total of any Medical Baseline Allocation permitted under Preliminary Statement, Part H, Paragraph 4, plus the applicable daily baseline quantities for the Customer's Baseline Region (as described on the Baseline Region Maps and in the boundary descriptions which are in conjunction with such Baseline Region Maps) shown below: (T)
