APPLICATION AND CONTRACT FOR GAS AND/OR WATER SERVICE

TO SOUTHERN CALIFORNIA EDISON COMPANY:

The undersigned Applicant hereby requests you to supply gas and/or water service and to deliver same to and for the equipment hereinafter described, at the location shown on the reverse side hereof, in accordance with the applicable rates and rules of the Utility.

Applicant hereby agrees to the following:

1. The Utility has made available for inspection its applicable rates and rules. Applicant agrees to comply therewith, and with any changes or modifications thereof which may be authorized from time to time by the Public Utilities Commission of the State of California.

2. Applicant's attention has been directed to the rate schedules applicable to the service herein described, and Applicant has elected to take and pay for service under Schedule for a minimum period of months. As specified in this schedule, Applicant elects the following optional provisions:

3. Applicant hereby grants to the Utility a right of way for any lines which may be necessary to build on Applicant's premises for the purpose of making delivery hereunder. Where Applicant requests facilities which are in addition to, or in substitution for, the standard facilities which the Utility normally would install, the extra cost thereof shall be paid by Applicant.

4. This contract shall at all times be subject to such changes or modifications by the Public Utilities Commission of the State of California as said Commission may, from time to time, direct in the exercise of its jurisdiction.
